### **Sponsor Trademarks/Sponsor Materials**

Subject to the terms and conditions of this Agreement, the Sponsor grants to LIADO and/or their designee a limited license and right to use Sponsor's trademarks, trade names, and logo designs and company descriptions as prepared and delivered by the Sponsor, in any medium of advertising, marketing materials, and/or promotional goods distributed solely in conjunction with the Event and in accordance with Sponsor's trademark usage guidelines.

### **Company Identification & Logo**

### **Cancellation & Termination**

LIADO reserves the right to terminate any sponsorship for any and/or no reason at any time. The LIADO President, Vice President and/or their designee has the authority to terminate a sponsorship. Notice of sponsorship termination must be provided to the Sponsor in writing at the address provided by the Sponsor on this Agreement unless Sponsor has provided LIADO with a change of address. LIADO may terminate this agreement at any time for any reason. Upon such termination, LIADO shall return to the Sponsor any materials donated by the Sponsor for the event, but any and all Sponsorship fees paid are non-refundable.

### **Unavoidable Casualty**

Should a sponsored event be cancelled, closed, curtailed or adversely affected by any cause not within reasonable control of LIADO, including but not limited to, fire, flooding, hurricanes, lightning, earthquake, sinkholes, explosion or destruction in whole or in part of machinery, equipment, or failure of supply of materials, discontinuation of supply or power, government interference, civil commotion, riot, war, strike, labor shortage or disturbance, transportation difficulties or any cause beyond the control of the of the LIADO organization. LIADO is under no obligation to provide a sponsor with a refund of all or part of the Sponsor's donation. If it becomes necessary to cancel an event, the event may or may not be rescheduled. A Sponsor's donation is non-refundable, however, LIADO may at its sole discretion provide a sponsorship opportunity approximate or equivalent for a future event.

### **Conflicts**

Sponsor shall indemnify, defend, and hold LIADO and its directors, officers and members harmless from and against any claims arising out of, or relating directly or indirectly to, content on their respective websites, use of Sponsor's trademarks and logos, and Sponsor materials. Sponsor will give LIADO prompt written notice of any claim or suit coming within the purview of these indemnities. This indemnification shall survive the expiration or termination of this Agreement.

## **Governing Law and Venue**

The laws of the State of Florida shall govern this agreement, and in the event of any dispute, venue for all proceedings shall be in a court of appropriate jurisdiction in Pasco County, Florida.

## **No Sponsor Endorsement**

LIADO does not endorse any aspect of a Sponsor, a Sponsor's business, services, products, or message. LIADO's display of a Sponsor's logo or branding message does not imply an affiliation with the Sponsor other than as outlined within the Sponsor's application and this Agreement; any implied affiliation is accidental. LIADO will reject any sponsorship applications where the involvement of the application may compromise the public perception of LIADO or its ability to act in the best interests of the public. A Sponsor's participation in a LIADO event and the views and opinions expressed by a Sponsor do not state or reflect those of LIADO its officers, agents or members, and must not be interpreted by the public as LIADO making a statement or taking action that directly or indirectly advocates or endorses the Sponsor, its business, organization, products, or services.

## **Policy, Personal Views, and Content Message**

- A. LIADO exercises sole discretion over the eligibility to participate in as a sponsor according to the terms of this Agreement. - C.   2. Promotion or depiction of any profanity, obscenity, sexually oriented products, materials, or activities.
  3. Promotion or depiction of any bigotry, prejudice, discrimination, and/or hate.
  4. Promotion or depiction of firearms, explosives, weapons, and/or glorification of violent acts.
  5. Promotion, glorification, or depiction of any illegal or inappropriate products, activities, or materials.
